THOSE WHO DEPOSIT THE FULL AMOUNT WILL RECEIVE PRIORITY IN THE QUEUE AND WILL RECEIVE THEIR GAMERUNNER SOONER.

AT THE TIME OF SHIPPING, YOU WILL BE CHARGED THE BALANCE, SHIPPING COST OF ABOUT \$30 BASED ON YOUR LOCATION, (US ONLY), AND SALES TAX IF APPLICABLE (CA & NV). INTERNATIONAL SHIPPING WILL BE HIGHER!

Items that are returned for manufacturer failures or defects which are, or should be, immediately apparent, are accepted only for 30 days after receipt of product. In case of a replacement part only, we must receive the defective part before we ship out the replacement part. If the part to be replaced was clearly defective, GameRunner will cover the cost of shipping and replacement.

// DAMAGE CAUSED BY CONSUMER //

Any damage done to the product by the consumer, (other than normal wear and tear) such as; attempts to alter the internal components which lead to malfunction of the product or any part therein, shall void all warranty to any and all parts affected.

ACCEPTANCE, RETURN:

It is Customer's responsibility to inspect delivered goods and report any claims in writing to Seller within ten (10) days of the date of delivery, ("timely notice"). Unless goods are returned for breach of warranty or specification, Seller is under no obligation to accept a return of the goods. Without timely notice from the Consumer, Seller shall have no further responsibility and Customer shall be deemed to accept the product with
